

Barber Shop License Application

This completed application and license fee of \$72.00 must be mailed at least 30 days before the anticipated opening day. For additional information refer to Iowa Code 157.13(1) b, available on the web site at www.idph.state.ia.us/licensure/Barbering.aspx?pg=Laws

- New Shop License.** A shop license is issued for a specific location to a specific owner(s). This shop was not bought from a previous owner or located at a different address.
- New Shop Location, same owner.** 645-subrule 21.11(1) a shop license shall be issued for a specific location. You moved location of your existing shop. A change in location or site of a shop shall require submission of an application for a new license. **You must return the original shop license from the previous location with this application.**
- Change in ownership of an existing shop.** 645-subrule 21.11(1) a shop license is not transferable. A change in ownership of a shop shall require the issuance of a new license and payment of fee required by 645-subrule 5.2(8).

Instructions/Checklist for shop application

The following is a list of the supporting documents and fees required for a shop. It is the applicant's responsibility to see that all required documents and fees reach the board office.

- Non-refundable fee of \$72.00. Check or money order **must** be payable to the Iowa Board of Barbering.
- Complete and sign the application in ink.
- Enclose the original license certificate if the shop has a change in location. Print CLOSED on the back of the certificate, along with the date the shop closed at that location.
- Return the original license certificate **if** the shop has a change in ownership. The previous owner must return the original license certificate. Print the date that the transfer in ownership became effective on the back of the certificate.
- If you answer "yes" to questions 6 through 11: (1) attach a signed letter of explanation, (2) provide the details of the incident, including the court or legal documents related to each incident, and (3) include information on any treatment program(s) you have attended. You must answer "YES" even when a conviction or judgment has been deferred or expunged from your record.

An applicant who has been denied licensure by the board may appeal the denial and request a hearing on the issues related to the licensure denial by serving a notice of appeal and request for hearing upon the board not more than 30 days following the date of mailing of the notification of licensure denial to the applicant. The request for hearing shall specifically delineate the facts to be contested at hearing.
