





IGTP Monthly Census





DG-SPS/SBIRT Guidance



DG-SPS/SBIRT Guidance

- **SBIRT** is an integrated, evidence-based approach that offers providers the tools to effectively and efficiently screen individuals for risky substance use and problem gambling
- **SBIRT** stands for Screening, Brief Intervention and Referral to Treatment and refers to the following processes:
 - Screening: Universal screening for quickly assessing use and severity of substance use and problem gambling.
 - Brief Intervention: Brief motivational and awareness-raising intervention given to individuals determined to be at risk for problematic substance use and gambling.
 - Referral to Treatment: Referrals to specialty care for individuals at high risk for a substance use or problem gambling disorder.

DG-SPS/SBIRT Guidance

- A service historically offered as part of the **SBIRT** process has been Brief Treatment. Although Brief Treatment can be a referred service, it is now funded as SBIRT (Early Intervention for July-August).
- **SBIRT** services are to be provided by substance use and problem gambling treatment providers in a variety of locations outside of a treatment center.
 - Examples include primary care settings, schools, and casinos.

DG-SPS/SBIRT Guidance

- DG-SPS (Disordered Gambler SBIRT Pre-Screen and Screen)
 - May be used in the SUD Treatment setting to identify patients whose gambling may be causing problems
 - Not a billable activity under the IPN
 - SBIRT may be billed for a positive DG-SPS, and Brief Intervention and/or a Referral To Treatment is provided.
 - SBIRT activities may not supplant Licensed SUD Treatment Hour requirements.

New Service Community Outreach

- Amended Contracts will allow for use of PG treatment funds for **Community Outreach**
- Contractors may conduct, support, and participate in collaboration and community outreach activities that establish the contractor as a primary treatment resource for substance use and problem gambling in the Service Area and statewide.
 - Presentations, Meeting Attendance, Referral Network Building
- Travel Time may be included in the duration reported for the activity (must be documented in the Service Note)
- **Gambling Education Services** Log will be used to report and document Community Outreach activities.

Monitoring, Reporting & Claims

- Education Services Export option
 - Filters can be used to see a specific month
 - Date Field – example: **01/01/2020:01/31/2020**
 - Downloads in Excel
- SSRS Report
 - IPN Problem Gambling Treatment Reports (I-SMART) Folder
 - IPN Community Outreach Detail
 - Use to see detail and errors
 - Unit Error = Duration not an increments of “30”
 - Participant Field Blank Error = Participant field does not have a value.
 - Provides claim amount for the month (Top Box above detail)



- Eligibility – The following may be taken into consideration:
 - **Burden of gambling related debt reduces the patient income to or below 200% of the Federal Poverty Level**
 - **Patient is without other financial resources to pay for the problem gambling treatment service(s)**
- No patient should be denied services due to financial concerns.

 - \$260,000 reductions taken for July-December underutilization.
